

Helpline House is hiring a Social Work Supervisor (job description below). This position must be able to clinically supervise staff with Associate level licenses, as well as the Helpline House social work staff. We would also like this position to provide therapy to a very small caseload, if possible.

We have the position posted as .8 FTE but can be flexible. This could be an ideal hybrid position between joining Helpline House staff and continuing private practice, or simply be a home for someone wanting to provide clinical supervision as well as individual therapy.

PURPOSE: Provides supervision and management to social service programs that support the mission of Helpline House. RESPONSIBLE TO: The Executive Director

RESPONSIBILITIES:

Program:

• Develop, implement, and monitor programs, including direct client services and referral to service providers.

• Support volunteer services through developing and implementing formal and informal training opportunities. Administration:

- Monitor client database and provide monthly service statistics.
- Lead or assist in various community initiatives and education as directed.
- Report out on social work program in routine agency meetings.
- Facilitate weekly clinical social work meetings.
- Monitor all training and professional practices and policies.
- Maintain relationships with educational institutions. Select interns and arrange for their training and supervision.

Fiscal:

- Monitor client support funds.
- Assist in the development of the annual budget and related grants.

Personnel:

- Assist with the hiring of social work staff.
- Supervise, mentor, coach, evaluate and direct social work staff.
- Maintain caseload equity.
- Assist with and monitor professional growth and continuing education of social work staff.
- Provide clinical supervision.

Direct Service:

- Provide back-up social work coverage for staff as needed.
- Carry limited client caseload.
- Other Duties as Assigned.
